**Wisconsin Technical College System (WTCS)
and Marian University**

**B.S. Middle-Secondary Education
Major Program Technology Education
(Wisconsin License #220)**

WTCS colleges will provide general and content-specific coursework in the areas of graphic communication technology, construction, manufacturing, engineering, and transportation to meet the content guidelines set forth by the Wisconsin Department of Public Instruction (DPI); and Marian University will provide general and pedagogical coursework to meet the requirements for the bachelor of science degree and the educator licensing requirements for Technology Education (220) license for middle-secondary level.

Together the Institutions agree:

- 1. WTCS students complete an approved Associate of Applied Science (A.A.S.) degrees and a prescribed cluster of broad-based technical courses to gain the required content-specific skills and knowledge required for technology educator licensure program;**
- 2. Marian University recognizes successful completion of the approved WTCS, A.A.S. degree as sufficient to warrant acceptance of credits toward the Bachelor's degree In Middle Secondary Education, Technology Education; given such, WTCS students will meet Marian criteria for junior status (60 credits);**
- 3. WTCS students are accepted into the teacher education program at Marian University, provided they meet the standard admission requirements of the university and teacher education department as published in the current Marian University Undergraduate Academic Bulletin;**
- 4. Determinations of transfer credits will be made by each respective institution. Courses which have not been already identified as transferable general education courses or program courses, may be reviewed on an individual basis;**
- 5. Students complete the Bachelor of Science degree for Middle-Secondary Education, Technology Education at Marian University, with a minimum of 120 credits, including 30 credits of upper level coursework from Marian University;**

- 6. Upon meeting all program and degree requirements, Marian University entitles teacher candidates through DPI for the Technology Education (220) license;**
- 7. All WTCS students pursuing this program will be advised of program and licensure requirements, including any testing procedures, through the enrolment management, marketing, and advising efforts by both institutions;**
- 8. WTCS students applying specifically for this program will be classified as undergraduate students in the Marian University Adult Studies program, subject to the Adult Studies Undergraduate Tuition rate as reflected in the Marian University Undergraduate Academic Bulletin. The 10% discount rate agreed upon in the executed MOU between WTCS and Marian will apply;**
- 9. The institution where students take the most credits will disperse the financial aid. WTCS Colleges will provide financial aid for courses the student takes within the A.A.S. curriculum; furthermore, the additional WTCS broad-based coursework needed for licensure, but not part of the A.A.S. degree, will be aided as preparatory coursework by WTCS Colleges in accordance with Federal Student Aid guidelines. If students enroll concurrently at both institutions, students will be required to sign a consortium agreement confirming the disbursement of financial aid and identifying course enrollments in the program. WTCS College academic advisors and Marian academic advisors will verify and document that students have signed such agreement upon registration;**
- 10. WTCS Colleges agree to provide Marian with student performance data for content area courses for the purposes of annual reporting to DPI on or before September 1 for the previous academic year;**
- 11. The agreement becomes effective Fall 2020.**




