² Final cost is for tuition and fees only (per student). Books, additional supplies/materials, online fees, pre-course orientation, student life (SGA) fees (if applicable), student accident insurance premium, and testing fees (if applicable) are not included. Students not associated with a fire department will need to pay a WCTC student activity fee (which is not denoted in the final cost).

³ Students attending these courses are required to meet certain health care requirements before being allowed to participate in clinical experiences, which may result in additional expenses (please see below for more information). The tuition and fees listed do not include mandatory insurance coverage (\$4.50 per semester).

⁴ Amount reflects technical studies courses (38 credits) required for Technical Diploma completion, National Registry testing eligibility, and WI licensure eligibility. Upon completion of these courses, students wishing to obtain their Paramedic Technician Associate Degree are required to complete an additional 28 credits of general education courses. National Registry testing fees are not included in the denoted amount; National Registry testing fees are separate/additional.

⁵ Additional fees may apply for students who choose to obtain field experiences through providers that charge for those experiences. Field experiences are made available at no additional cost through several non-charging field sites.

Emergency Medical Technician (EMT): NREMT Practical Testing (Individual Station Retest)	\$25.00
Advanced EMS NREMT Practical Testing (Advanced EMT, Intermediate [I-12], and Paramedic)	\$250.00
Advanced EMS NREMT Practical Testing (Individual Station Retest)	\$55.00

⁶ Fee is per student for full examinations or practical station retests.

Students attending Firefighter I, Firefighter II, and WCTC clinicals must meet certain health care requirements prior to being admitted into the course or clinical setting. The cost of meeting these requirements can vary given the student’s health history and the use of different medical providers and health care plans.
